In pursuance of Hon'ble Gauhati High Court's Order No. HC.IX/2019/43/RG dated 02.04.2020 and Order No. 19 dated 24.03.2020 for filing and hearing of cases involving extreme urgency in the District Judicial Court, Baksa, Mushalpur, the following roster of Judicial Officers is prepared. The Judicial Officers shall deal with such cases including remand matters related to fresh arrest and extension of remand.

- 1. District & Sessions Judge, Baksa, Mushalpur** will be on roster duty on **8<sup>th</sup> and 17<sup>th</sup> April of 2020.**

- 5. Addl. Chief Judicial Magistrate, Baksa, Mushalpur** will be on roster duty on **6<sup>th</sup>, 8<sup>th</sup>, 10<sup>th</sup>, 12<sup>th</sup>, 14<sup>th</sup>, 16<sup>th</sup>, 18<sup>th</sup> April of 2020.**
- 6. Secretary, District Legal Services Authority, Baksa, Mushalpur** will be on roster duty on **6<sup>th</sup>, 7<sup>th</sup>, 9<sup>th</sup>, 18<sup>th</sup> April of 2020.**
