Applications are invited in Standard Form published in part IX of the Assam Gazette from intending candidates for filling up the post shown below under the establishment of the District and Sessions, Judge, Baksa, Mushalpur.

Eligibility criteria:

1. Candidate must be an Indian citizen as defined under Article 5 & 6 of the Constitution of India.
2. Candidate must have passed minimum class VIII from a recognized educational institution. Those who have passed class XII or have higher qualification shall not be eligible for the post.
3. Candidate must hold valid LMV Driving license issued by a competent authority.
4. Candidate must not be less than 18 years or above 38 years of age on 01-07-2021. The upper age limit will be relaxable as per existing Government norms.

Selection process:

5. The selection process will be held in two stages. The first stage would be driving /skill test and the second stage would be interview/viva voce .
6. The applications in standard form along with self attested supporting documents will be received only through e-mail. The candidates whose applications are found valid would be called for driving /skill test in the first stage and based upon the performance in the driving/skill test candidates would be shortlisted and only those candidates who qualify the driving/skill test would be called for appearing in the interview/viva voce in the second stage. The final selection will be made on the basis of total marks obtained by the candidate in the driving/skill test and interview/viva voce.

7. The place, date & time of the driving/skill test and the interview/viva voce will be notified in due course through official website.

Terms & Conditions:

8. Candidates must submit application in the Standard Form affixed with one recent passport size coloured photograph along with Self attested copies of all testimonials regarding educational qualification, age, caste, employment exchange registration, LMV driving license & forwarding documents (in case applying through proper channel).

9. Candidates must have registered their names in the employment exchange and the registration number along with the date must be mentioned in their application.

10. Candidates serving in Government Department should submit application through proper channel from his/her employer.

11. The application in standard form must be written legibly in block letters clearly mentioning the post applied for. The applicants must mention their mobile numbers in the said form without fail.

12. The application in standard form along with self attested documents must be scanned in one file (PDF format) and send it through e-mail to recruitmentbaksajudiciary@gmail.com

13. Complete applications received through e-mail at recruitmentbaksajudiciary@gmail.com in PDF Format on or before 12-07-2021 upto 4 PM will only be considered.

14. No applications will be accepted which is received late after the due date of submission of applications through e-mail.

15. Applications made in any other mode except as indicated above shall be summarily rejected without any communication.

16. Applications received without proper supporting documents or unsigned or without photograph or incomplete in any respect will be summarily rejected.

17. The provisional list of eligible candidates with allotted Roll numbers along with the date, time and venue of driving/skill test and interview/viva voce will be uploaded in the official website of Baksa district Judiciary (<http://baksajudiciary.gov.in>) and in the office notice board of this office in due course.

18. No individual call letters will be issued to the eligible candidates. Applicants are therefore advised to visit the official website regularly to get updated information.

19. The eligible candidates will be required to produce the hard copy of the original application in standard form along with the original testimonials regarding educational qualification, age, caste, driving license, etc for verification when asked for.

20. If any candidate is found to have suppressed his educational qualifications or given wrong information at the time of applying for job or later on, his candidature shall be rejected without any information to him with immediate effect and he shall also be liable to criminal prosecution as per law.

21. No TA/DA will be admissible to the candidates for appearing in the driving/skill test and interview/viva voce.

22. Canvassing directly or indirectly shall disqualify a candidate.

23. The selection will be purely on contingency basis terminable at any time.

24. All other matters which are not specifically provided in the advertisement shall be decided by the selection board.
